

**Notice of merger**

Dear business partners,

We would like to inform you about the changes that will occur in connection with the merger of the defunct company KVIP s.r.o. with its registered office at Vajnorská 135, 831 04 Bratislava - mestská časť Nové Mesto, IČO: 36 315 991, entered in the Commercial Register of the District Court Bratislava I, section: s.r.o, file no. 91977 / B, with the successor company BEKWOODCOTE s.r.o, with its registered office at Vajnorská 135, 831 04 Bratislava - mestská časť Nové Mesto, ID number: 31 364 951, registered in the Commercial Register of the District Court Bratislava I, section: s.r.o, file number: 6333 / B.

**With effect from 1 August 2021, KVIP s.r.o. will be merged, as a company merging with BEKWOODCOTE s.r.o., as the successor company.**
